This website is run by Cheverell Magna Parish Council. We want as many people as possible to be able to use this website. For example, that means you should be able to:

- Change colours, contrast levels and fonts
- Zoom in up to 300% without the text spilling off the screen
- Navigate most of the website using just a keyboard
- Navigate most of the website using speech recognition software
- Listen to most of the website using a screen reader (including the most recent version of JAWS, NVDA and VoiceOver)

We have also made the website text as simple as possible to understand.

AbilityNet (<https://mcmw.abilitynet.org.uk/>) has advice on making your device easier to use if you have a disability.

## How Accessible is this website?

We know some parts of this website aren't fully accessible:

- The text will not reflow in a single column when you change the size of the browser window
- you can't modify the line height or spacing of text
- some pdf documents aren't fully accessible to screen reader software
- live video streams do not have captions
- some of our online forms are difficult to navigate using just a keyboard
- you can't skip to the main content when using a screen reader

Scanned pdf documents do not comply with the Accessibility Regulations, but these documents can be provided in an alternative format or on alternative media on request.
